## BufferLABS US Equity Dynamic Buffer ETF

Seeks to reduce downside exposure

### What is a Dynamic Buffer ETF?

Dynamic Buffer ETFs use options strategies aimed to manage downside risk while maintaining upside participation. Unlike traditional defined outcome ETFs with fixed caps and buffers, BFLB actively manages its options positions to adapt to changing market conditions.

#### Fund Overview

The BufferLABS US Equity Dynamic Buffer ETF (BFLB) is an actively managed equity strategy that seeks to achieve capital appreciation with partial downside mitigation. The Fund uses a put spread collar options structure on SPY to provide asymmetric exposure to US equity market returns, participating in a greater percentage of market rallies than market sell-offs.

## Our Approach

BFLB differentiates itself through rolling and rebalancing options positions in response to market conditions to target desired portfolio characteristics.

Rather than holding a defined outcome structure until expiration regardless of market events, BFLB responds to market movement to maintain the target risk level and market-relative participation.

The fund uses the ADOPT model (Applied Dynamic Option Pricing Theory) to determine optimal buffer strategy positioning.

**New Sub-Advisor Risk.** BufferLABS has no experience with managing an ETF, which may limit its effectiveness.

**Buffer and Cap Risks:** There can be no guarantee that the Fund will be successful in its strategy to buffer against the Underlying ETF's losses. The Fund does not provide principal protection and an investor may experience significant losses on its investment, including loss of its entire investment. Because the amount of the Buffer and the corresponding Cap are determined separately each time the Fund adds exposure and will vary depending on market conditions and available options contracts, investors will not receive the protection of any particular fixed Buffer level.

**Options Risk.** Writing option contracts can result in losses that exceed the seller's initial investment and may lead to additional turnover and higher tax liability. Buying options is a speculative activity and entails greater than ordinary investment risks. **Special Tax Risk.** The Fund intends to qualify as a "regulated investment company" ("RIC"), however, the federal income tax treatment of certain aspects of the proposed operations of the Fund are not entirely clear. This includes the tax aspects of the Fund's options strategy, its hedging strategy, the possible application of the "straddle" rules, and various loss limitation provisions of the Internal Revenue Code of 1986, as amended. If, in any year, the Fund fails to qualify as a RIC under the applicable tax laws, the Fund would be taxed as an ordinary corporation. Certain options on an ETF may not qualify as "Section 1256 contracts" under Section 1256 of the Code, and disposition of such options will likely result in short-term or long-term capital gains or losses depending on the holding period.

**Active Trading Risk.** The Fund expects to engage in active and frequent trading of its portfolio securities and its portfolio turnover rate may exceed 100%. A higher rate of portfolio turnover increases transaction costs, which may negatively affect the Fund's return. In addition, a high rate of portfolio turnover may result in substantial short-term gains, which may have adverse tax consequences for Fund shareholders.

**Sector Risk.** To the extent the Fund invests more heavily in particular sectors of the economy, its performance will be especially sensitive to developments that significantly affect those sectors.

**New Fund Risk.** The Fund is a recently organized investment company with no operating history. As a result, prospective investors have no track record or history on which to base their investment decision. There can be no assurance that the Fund will grow to or maintain an economically viable size.

**Large-Capitalization Companies Risk.** Large-capitalization companies may trail the returns of the overall stock market.
