Q2 & YTD 2024 Review: Within the Small-Mid Cap Market, the B2000G (Small-Growth) Index led the quarter with a -1.82% return and the B2500G (Small-Mid-Growth) Index lagged with a return of -4.28%. Year to date, the BMIDV (Mid-Value) Index return of 5.46% led the Small-Mid Cap Market and the B2000V (Small-Value) Index return of -1.66% has lagged.

Important Information

1. Price-to-Earnings Ratio (“P/E Ratio”): Current share price of a stock divided by its earnings per share.
